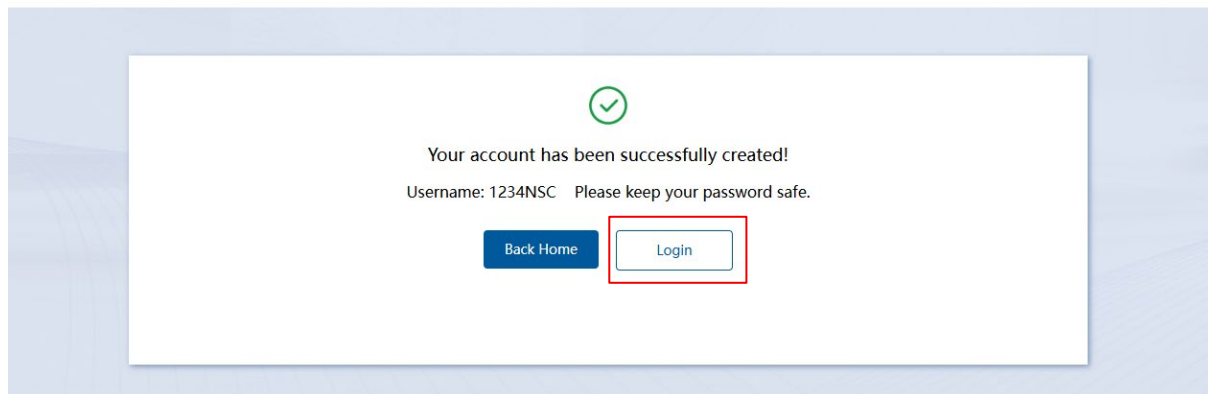

According to the requirements of the business departments of the General Administration of Customs, the Enterprise Qualification (Administrative Counterparty Unified Management 3.0) system has been updated. The specific contents are as follows:
1. Added the "double lost contact enterprise" prompt function. When an enterprise is handling qualification registration, change or cancellation business, if it receives the "double lost contact enterprise" prompt, please read the prompt content carefully and contact the local customs according to the prompt.
2. Enable the new version of the "Customs Declaration Unit Registration Certificate" function. After the enterprise completes the customs declaration unit registration, it can apply for the new version of the "Customs Declaration Unit Registration Certificate" online in the "Qualification Registration-Certificate Management" module. The application is limited to one application per day.
3. Added overseas inspection and customs verification functions for overseas registration. Enterprise that receive overseas inspection or customs verification requirements, please fill in and submit a statement of the situation as required.
4. Other overseas registration function adjustments: (1) When applying for recommended registration product details, some input requirements have been added; (2) The legal representation information is taken from the enterprise's qualification registration at the customs and cannot be modified; (3) Added a notice of extension of the review time limit.
