3. All documents should have text in English or Chinese or the application will most likely be rejected.

Floor plan should show processing areas, cooling storage and equipment if possible. We often see applications rejected because of unclear floor plans.

For specific processing methods attach a flow chart and/or a processing flow description. The flow chart should make it clear which products are produced in the process and show what raw material is used.



IMPORTANT: after sending the application, you must send an e-mail to insight@seafood.no.

- Mark your email with: «Kina - nyregistrering (pakken [eg. TT555]) vedlegg», and confirm that you have submitted the application. **This is important as you will receive two attachments that you have to sign, stamp and send back.**
- The attachments are:
 - «*Registration Conditions and Inspection Focuses for Manufacturers of Imported Aquatic Products*»
 - «*1.3.366 Egenerklæring, Kina, Single Window, 2022-09*»
- When we have received the attachments, we can send the application to GACC for approval.

after sending the application

- **IMPORTANT:** On many occasions GACC finds different errors in the application and will send it back to the NFSA for correction. On most occasions, the NFSA then must send the application back to the company for correction. The application status will then be “to be corrected by enterprise”. This means that you have to check your application feedback (see page 23), correct the application and submit it again.
- It is important to regularly check your application status for different feedback and corrections.
- The registration is **not** complete until GACC has **approved** the application. The status of your application can be found in the system at any given time.

Approved	If the overseas manufacturer of imported food meets the requirements, GACC shall approve the registration application and grant Chinese registration number to the enterprise.
To be corrected by authorities	If the submitted application does not comply with the requirements of GACC, and the contents shall be modified or supplemented by the competent authority of the country (region), and the application shall be modified by the competent authority of the country (region) and submitted again. It does not need to fill in a new application.
To be corrected by enterprise	If the submitted application does not comply with the requirements of the competent authority of the country (region) or GACC and it needs to modify or supplement the filled contents, the enterprise shall modify the application and submit it again. It does not need to fill in a new application.
